The law requires that only creditors or the person they appoint to represent them (their 'proxy' or attorney) are entitled to vote at the meeting. To attend the meeting, you must either:

- complete and send in the attached (Proxy) form.

If you want to be represented by an attorney, the details of the power of attorney must be provided <u>before the meeting</u>. This is a legal requirement. # Voting at the Meeting

Creditors attending the meeting by phone will be individually asked to state how they want to vote on each of the decisions at the relevant time during the meeting. If you can't attend the meeting (by phone), you can complete the attached Proxy Form to instruct your representative/proxy holder how to vote.

# **Asking Questions at the Meeting**

All creditors attending the meeting will be invited to ask questions at the relevant question times during the meeting. All creditors will be asked to state their name prior to asking any questions. I will address and answer each question asked at the time.

I cannot answer questions about your individual account or membership with the Youpla group during the meeting. I can only answer questions that are relevant to all members.

Minutes of the meeting will be available within 14 days after the meeting and may be made available upon request.
