Significant Engagements cont.

- ▶ Managing the receivership of Smart City Solutions Pty Ltd which provided “smart” bins to a number of councils around the country, but predominantly to City Of Melbourne. Following an unsuccessful sale campaign, we negotiated the sale of the business and assets to the secured creditor with all the employees at time of sale transferring over.
